1. This Invitation for Bids follows the General Procurement Notice (GPN) for this Project which will appear in The Zanzibar Leo Magazine dated 30th August 2018.
2. The Revolutionary Government of Zanzibar has set aside funds for the operation of the Ministry of Finance and Planning during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Proposed Construction of the Office Building for the Ministry of Finance and Planning at Mazizini-Unguja.
3. The Ministry of Finance and Planning now invites sealed bids from eligible National and International qualified Bidders registered or capable of being registered with the Contractors Registration Board, Tanzania in Class ONE (1) and Zanzibar Contractors Registration Board or respective registration board from the country of origin for carrying out the Proposed Construction of Office Building for the Ministry of Finance and Planning at Mazizini-Unguja.
4. Bidding will be conducted through the International Competitive Bidding procedures specified in the Public Procurement and Disposal of Public Assets Act No.11 of 2016 and are open to all Bidders as defined in the Act.
5. Interested eligible Bidders may obtain further information from and inspect the Bidding documents at the office of Tender Board Secretary, **Ministry of Finance and Planning located at Vuga, Zanzibar** from 8:30 hrs to 15:30 hrs

on Mondays to Fridays inclusive except on Saturday, Sunday and Public Holidays.

6. A complete set of Bidding document(s) in the English language and additional sets may be purchased by interested Bidders on submission of a written application and to the address given under paragraph 5 above and upon payment of a non- refundable fee of Tanzania Shillings One Hundred Thousand (**Tshs.150,000.00**). The method of payment will be bank deposit or transfer, payable to **Ministry of Finance and Planning, Zanzibar. All Bids must be accompanied by an Unconditional Bid Security in an acceptable form in the amount of not less than two percent (2%) of the Bid Price in the format provided in Section X (Forms of Security) of the Bid.
